Interdisciplinary, critical approaches committed to social justice and digital ethics are valued.

Texts authored by researchers with an institutional affiliation abroad (affiliated with foreign institutions) or with a predominantly international theme, approach and academic dialogue, contributing directly to the internationalization of *Pensar*. The journal publishes in Portuguese, English, Spanish, Italian and French, enabling this section in different languages.

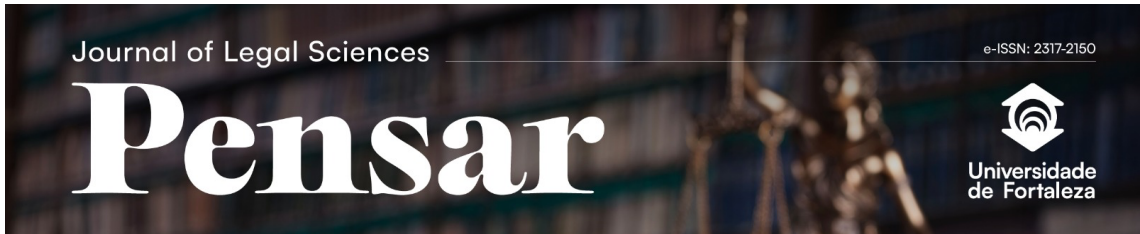
